The Story



Mrs. Pauleen Pamela Reid is an extraordinary educator,serving the nation for 40 years. Mrs. Reid received initial certification at Shortwood Teachers' College. She then advanced to the University of the West Indies where she earned a Bachelor of Arts Degree in English. She later graduated from Central Connecticut State University with a Master of Science in Educational Leadership. She has contributed a chapter to the scholarly text "Leadership for Success: The Jamaica School Experience (2017)". Edited by Dr. Disraeli M. Hutton and Dr. Beverly Johnson. She is the featured subject of the book 'Pauleen Pamela Reid, Leader Extraordinaire' authored by Dennesha Frazer.

Mrs. Reid's call to service is not confined to education as she serves as a Deacon at Burchell Memorial Baptist Church, a Lay Preacher and the Chairman for Church Mission.

Mrs. Reid's achievements have captured national attention, as she was Lasco Principal of the Year for 2010-2011 and a recipient of The Prime Minister's Medal of Appreciation for Outstanding contributions to education. She is also a Past President of The Association of Principals and Vice –Principals. Mrs. Reid was the founding Principal of Holland High School in Trelawny and is a member of The Advisory Board of The National College for Educational Leadership, and a member of its International Relations and Marketing Committee. Though officially retired, she currently serves as the Interim Principal at the newly branded Knockalva Polytechnic College.

Prof. Michael Boyne Director

A Fellow of the Royal College of Physicians and Surgeons, Canada, Professor Michael Boyne holds the Bachelor of Science (Hons), and the Bachelor of Medicine, Bachelor of Surgery from The University of the West Indies (UWI), Mona.

Prof. Boyne joined the staff of The UWI, Mona in 2000 as a Lecturer in Endocrinology in the Tropical Medicine Research Institute. He was promoted to Senior Lecturer in 2006. Over the period, Prof Boyne has established a record of distinguished original work in the field of the developmental origins of health and disease and diabetes research. This effort has made a substantial contribution to understanding the impact of maternal and early development factors in determining susceptibility to type 2 diabetes and obesity.

His excellent work has seen him receiving the Principal's Award for Best Research Publication for two consecutive years (2010-2011). He has also received grants as principal investigator and acted as co-investigator on several large research grants. He has several international collaborations, including with the University of Southampton and the Liggins Institute, New Zealand, Johns Hopkins University, Loyola University and Kings College, London.

Prof Boyne is a well-respected teacher, having taught at the undergraduate and postgraduate levels in endocrinology and nutrition.



Vivienne Jones Director

Vivienne Jones is a graduate of the University of the West Indies and is a former Vice President of Operations at The Victoria Mutual Building Society (VMBS). In her 26year sojourn with VMBS, she has served the organisation in several capacities at the senior management level including, Systems Manager, Branch Manager and Assistant Vice President, Branch Operations. Mrs Jones has also had oversight responsibility for the operations of the Overseas Offices, the Marketing and Mortgage departments and the local Branch network.

A current trustee of the VMBS Pension Fund, Mrs Jones is a remarkable leader who has held directorship positions in several of VM Group subsidiaries.

During Mrs Jones' outstanding career at VMBS, she was integrally involved in the implementation of VMBS' On-line Real-time Computer System in 1986 – a first in Jamaica and the establishment of the International Branch. The Canadian Representative Office, the TeleCare Customer Service Centre, the centralisation of the branch correspondence and accounting functions were achieved under her distinguished stewardship.

An ardent Anglican, Mrs Jones currently serves as a mentor to wards of the State housed at The St Andrew Parish Church Home for Girls.

Dr. Veronica Campbell Brown Director

Jamaican sport icon and the nation's most decorated track and field athlete, Veronica Campbell Brown, CD joined the Board of Directors of the VM Foundation in January 2023. Campbell Brown, who is an eight-time Olympic medallist has won more than 46 medals at international athletic events, earning the distinction of being the first athlete ever to win the full slate of IAAF sprint titles.

The 2009 UNESCO Champion of Sport awardee announced her retirement from the sport in 2021, capping a storied career marked by many pioneering achievements including being the first Jamaican track and field athlete, male or female, to win a major senior international title in the 100-metre event.

Dr. Campbell Brown firmly focuses on improving lives through various philanthropic endeavours including the purposeful work of the VM Foundation.



Dr. Lorna Gow-Morrison Director

Lorna Gow-Morrison is a highly accomplished and respected figure in the field of education. She graduated from the University of the West Indies with a PhD in Teacher Education and holds an M.Ed. in Educational Psychology.

With over 40 years of teaching experience, she has given herself to the service of over 10 educational institutions including: Shortwood Teachers' College; University of West Indies, Mona; University of Technology (UTech); Mico University College.

Dr. Gow-Morrison has served as Principal at Sam Sharpe Teachers' College, and as a Facilitator at the National College for Educational Leadership, in the Ministry of Education and Youth.

Her impact extends beyond her institutional roles. She has made significant contributions to educational research and literature. Her book, 'Action Research in Teacher Education: A Caribbean Perspective, co-authored with T. Ryan, demonstrates her commitment to advancing educational practices and fostering a Caribbean perspective in teacher education.

Prof. Anthony Harriott Director

Anthony Harriott was promoted to the rank of Professor in January 2006 and was appointed Director of The University of the West Indies Institute of Criminal Justice and Security and Head of the Department of Government in that year.

Prof Harriott has served as a member of several local, regional and international expert groups. These include, the International Scientific and Professional Advisory Council of the United Nations Crime and Criminal Justice Programme, the CARICOM Regional Task Force on Crime. He is a member of several professional organisations including, the Academy of Criminal Justice Sciences and the America Society of Criminology and has presented several scholarly papers at the meetings of these organisations.

Prof. Harriott is the author of several scholarly articles and the author/editor of six books primarily on the issues of violence, and policing in Caribbean societies. These include Police and Crime Control in Jamaica: Problems of reforming ex-colonial Constabularies, and Understanding Crime in Jamaica – New Challenges for Public Policy. He has also authored and co-authored several technical reports in his field of expertise.

Prof. Harriott is the recipient of various academic awards, including the Principal's Award for Best Researcher in the Social Sciences, Best Publication, and research project attracting the most funding.



Valrie Grant Director

Valrie Grant is a serial entrepreneur, Geospatial and Strategy consultant. She is the Founder and Chairwoman of GeoTechVision, a knowledge services company built into an international reliable and quality provider of a range of customised services and data-driven solutions to governments, NGOs and corporate entities. Valrie is a lifelong learner, who is passionate about Technology and Entrepreneurship and relishes every opportunity to mentor women entrepreneurs and young people. Her latest initiative is EduTechAid which seeks to respond to the inequality of access to digital tools in education and empower youths. She has served on several national, regional and international Boards and Committees such as the World Geospatial Industry Council (WGIC) and the United Nations Global Geospatial Information Management (UN-GGIM): Americas Private Sector Network for which she is the current Chair. Board Committees

- Monitoring the budget and other financial issues including facilitating periodic governance audit from the Internal Audit Division of the VM Group;
- Developing instruments of authority for the Foundation;
- Ensuring that all matters conducted by the Foundation is in keeping with best practices and Jamaica's legal and fiscal requirements;
- Ensuring that all statutory requirements are upheld including ensuring that all financial reports are accurate and submitted on a timely basis;
- Establishing meaningful but realistic communication guidelines between the Foundation and Grantees

- Advising on communication and PR about the Foundation within the VM Group and to the members and general public; and
- Ensures and supports good governance by promoting the healthy development and functioning of the Board, its committees and individual members

VM Scholars

Scholarship Update



In 2023, thanks to your incredible support, promotion and investment, applications for our scholarship program, VM Scholars saw unprecedented growth. From scholarships and bursaries to laptop or tablet donations and mentorship programs, the VM Group has been dedicated to transforming the lives of students through various forms of assistance for more than three decades. 2023 was no different. In fact, we revved up and won! We received 425 applicants for our suite of scholarships and bursaries - a 55% increase over 2022! Your generosity enabled us to disburse \$7,150,000 in scholarships and bursaries, supporting 74 exceptional students across secondary and tertiary levels. The value of STEM and Master Plan Bursaries for tertiary scholars increased from \$200,000 to \$250,000, showing our commitment to their continued success, and the positive changes we can make as the Foundation continues to grow. We supported 3 successful PEP candidates with \$60,000 annually for 5 years at their respective high schools, along with 62 high school students receiving one-year bursaries. Meanwhile, 9 tertiary students in STEM fields, new university entrants, and post-graduates received awards ranging from \$250,000 to \$450,000 annually. We are proud to note that we not only invest in their academic success, but we also provide mentorship for all our recipients- and we are proudly the only Foundation to provide mentorship to all our scholarship recipients. Our high school and university scholars receive a mix of individual and group mentorship to ensure they have the right mindset to transition to a higher level of education and become alobal citizens.

Mentorship Update



Since 2021, the VM Foundation has been revving up its mentorship efforts, adding an extra boost to its programs. We have added even greater value to many of our programmes by offering guidance and support through mentorship sessions tailored to their needs. Last year, we hosted three awesome group sessions for high schoolers, led by the pros at We Imagine. Huge thanks to our VM Team Members and Board Members for their invaluable contributions in curating and presenting sessions on Leadership, Public Speaking, and Time Management. Additionally, our partnership with VM Wealth allowed us to provide executive mentorship opportunities for tertiary scholars, with Dennise Williams of Financially Focused TV graciously hosting a mentorship session in November 2023. We are deeply grateful for the commitment and support of all involved in nurturing the next generation of leaders.

VM UpLift

From April to June 2023, football teams from 24 participating schools hit the field for the VM UpLift Under 13 Football Competition in St James. Words fail to capture the joy we felt, and the exuberance we witnessed as teams gathered to play again after a challenging three-year hiatus during the pandemic. Despite the break, our dedication remained unwavering as we continued to support players, coaches, and schools with gears, training, and other assistance.

In conjunction with the competition, we hosted complementary training workshops aimed at establishing a sustainable, holistic programme that fosters youth development through sports. These workshops were held in October and were attended by athletes, parents, physical education teachers, and coaches from participating schools. These sessions facilitated collaboration among peers from various schools, offering invaluable insights that extend far beyond the confines of the field, including discussions on financial literacy. With one session tailored for student-athletes and another for coaches, the workshops catered to the specific needs and interests of each group. By empowering coaches with the tools and knowledge to promote sustainability within their schools, we continue to strengthen our impact on youth development through sports. A total of 44 student-athletes from 19 schools, along with 22 coaches, participated in these enriching sessions. We are thankful for the collaboration with Project GOLD and the opportunity to provide valuable training on nutrition, health and technical aspects of the game.

VM EnRich

Our EnRich calendar typically begins in August with the engagement of selected schools that have expressed interest in offering our programme as an extra-curricular activity during the upcoming school term. From September to May of each academic year, we provide support for the initiation and continuation of club activities and the establishment of students' social enterprises.

The VM Foundation closed the first guarter of 2023 with the much anticipated EnRich Expo-a vibrant showcase of innovation, creativity and entrepreneurial spirit among the most talented set of highschoolers. The EnRich Expo featured captivating presentations from students on their social enterprise projects, a spirited pitch competition and invaluable insights from esteemed leaders in social entrepreneurship and technology. We welcomed a cohort of 61 students, from 4 schools, accompanied by 14 dedicated teachers, who brought their passion and ingenuity to the forefront. Their energy was palpable, igniting the expo with a sense of possibility, promise, and friendly competition. Taking our theme "Rev Up and Win" very seriously, the team of social enterprisers from Holy Trinity High School was crowned as the winner of the pitch competition, earning them a well-deserved prize of \$200,000. This prize money will not only support the continuity of the VM EnRich programme but also empower participating students to continue their journey of exploration and innovation through their social enterprises.

VM EnRich cont'd

Following the success from the 2022-2023 cohort at the May 2023 VM EnRich Expo, the programme grew from 4 to 10 schools by September. During this expansion, VM EnRich became more geographically diverse. This programme has now been successfully implemented in 10 high schools in Kingston, St. Catherine, Clarendon, Manchester and St. Elizabeth, involving nearly 500 students in a six-week training programme. This programme equips students with knowledge of social innovation, entrepreneurship, financial literacy, and digital literacy, as well as essential skills for learning, leadership, life, and work. VM EnRich engages students in all grades, with an emphasis on grades seven to nine, and guides them on developing their own businesses to address a number of social and environmental needs. Students are exposed to other viable business and professional options, outside of the traditional careers. Students are also enriched with a sense of volunteerism, community, and giving back. We have seen some extraordinary ideas and businesses emerge from this programme, and love to see the students' enthusiasm around social entrepreneurship.

VM Ignite

VM Foundation further extended its partnership with the Waltham Park New Testament Church of God (WPNTCOG), the Shortwood Teachers College and the University of Technology Jamaica, to deliver the Ignite programme, aimed at fostering holistic development, leadership among youth and of course, with an emphasis on financial literacy. In 2023, this dynamic partnership saw the implementation of a transformative nine-week programme comprising three modules, each designed to address key aspects of personal growth, leadership development, and financial literacy. The first two modules focused on the psychosocial dimension, exploring topics such as understanding oneself, love languages, and family systems, while the third module delved into essential financial literacy concepts. As part of this annual partnership, VM Team Members play a pivotal role in delivering financial literacy sessions during the third module of the programme, covering crucial topics such as assessing one's financial situation, goal setting, savings and investment strategies, understanding debt and credit management, and the path to home ownership. We are delighted to report that a total of 300 students had the opportunity to participate in this enriching programme, benefiting from valuable insights, skills, and knowledge that will empower them to navigate life's challenges with confidence and resilience.

USAID – Project IMPACT

We are delighted to share the inspiring story of VM Impact, a transformative initiative launched in 2022 by the VM Foundation in collaboration with USAID through its Local Partner Development Programme (LDP). Through this partnership, we embarked on a journey to empower youth in the Waltham Park Gardens and surrounding communities with the tools and resources they need to thrive as entrepreneurs and agents of positive change. At the heart of the VM Impact initiative was a crime prevention and entrepreneurship training programme, carefully curated to support young individuals who may have been exposed to crime, offering them a pathway to economic empowerment and self-reliance. Through a collaborative and holistic approach, we provided participants with essential financial principles, psychosocial support, seed funding, equipment, business supplies, and invaluable guidance in business planning and management. A graduation ceremony was held on March 12, 2023 at the VM Group's Half-Way Tree location to commemorate the efforts of the 13 young entrepreneurs who completed the programme. We are immensely proud to announce that some of these talented individuals have already been welcomed into the VMBS family, now embarking on a new chapter of financial empowerment and growth. The event was hosted by VM Group's President and Chief Executive Officer, Mr. Courtney Campbell and included the representation of USAID LPD through Chief of Party, Morana Smodlaka Krajnovic and

Programme Coordinator, Kameka Chung. The event was also attended by a number of VM executives, as well as two of the project's Community Liaisons, Mr. Michael Forth and Mrs. Marilyn Cain-Wright. As we reflect on this moment, we are filled with gratitude for the confidence given to us by of our partners, donors, and other stakeholders, whose belief in the power of education and entrepreneurship has made this initiative possible. Together, we have demonstrated the profound impact that collaborative efforts can have in transforming lives and building brighter futures. The completion of this project marked a significant milestone in our journey as a relatively new Foundation, and our path towards empowering young minds and fostering entrepreneurship. Indeed, this validates all our efforts to introduce innovative ways to transform lives.

Jamaica Library Service National Reading Competition and Financial Literacy Challenge

Teaming up with the National Library Service once again, the VM Foundation launched the Financial Literacy Challenge for the National Reading Competition in August 2023. This is our second time supporting the competition, and we are happy that we could build on this 36th staging in this way. Inclusion of the Financial Literacy Challenge complemented the competition's emphasis on reading, broadening participants' exposure to key concepts for financial empowerment. Participants who made it through the parish finals in the age groups 9-11, 12-14, and 15-20 enjoyed the series of specially designed financial videos and booklets. With 2,676 entrants, including 2,474 children and 202 adults, we recorded a 38% increase in participants relative to 2022, and we also beat our target of 2500 set for 2023! Youth participants who made it through the parish finals really enjoyed racing through a series of specially designed financial videos and booklets. Our aim was to enhance financial awareness among youth and engage them in a fun way. Mission accomplished! This is our second year supporting the Jamaica Library Service's National Reading Competition, and we are happy that we could have added a financial literacy component to the 2023 staging.

At the VM Foundation, we are serious about community development. From giving a helping hand to local projects through our small grants to partnering and sponsoring events like the National Leadership Prayer Breakfast Charity, we are in the driver's seat for sustainable change.

In 2023, we teamed up with the Esher/Martin Citizens Association to **Rev Up** their Summer Programme with some Social Entrepreneurship training. These two rural districts in St. Mary have been working hard to build and uplift their neighbourhoods with various initiatives. During the second week of July, we paired with Training Consultants and Facilitators from Young Women/Men of Purpose (YWOP/YMOP) to deliver Social Enterprise and Financial Literacy Training. We're thrilled that 63 participants, (36 males and 27 females), had this opportunity to learn about social entrepreneurship, managing one's finances, and being an effective leader. Of course, this is a group effort- together, we are building stronger communities and a better Jamaica.

It is no secret that land acquisition and getting a legal title to prove ownership are challenging tasks for many Jamaicans and are always very controversial topics. However, when accessible, land ownership and the strategic use of the land owned can be a vehicle to many other transformative opportunities. In recognition of this potential, the VM Foundation has committed \$30 million to support at least 400 Jamaicans in registering and obtaining land titles under a new partnership with the National Land Agency (NLA) of Jamaica. Over a three-year period, this collaboration will seek to legalise ownership of parcels of land for persons living in specific parishes in Jamaica. Persons can apply for this initiative through the NLA to receive grants of up to \$75,000 to offset costs of surveying their land- no doubt one of the largest expenses and biggest barriers to legalization. Samantha Charles, CEO of the VM Foundation, at the launch of this initiative in February 2023 highlighted the low levels of land registration in Jamaica and expressed enthusiasm for the initiative's potential to empower citizens and strengthen the processes for land administration and management. Leaving attendees with a key reminder of the importance of land ownership and its potential to enhance financial security and improve quality of life, she said "the best investment on earth is earth." Cheriese Walcott, CEO of the NLA, commended the partnership, emphasizing its role in addressing barriers to land registration and enabling citizens to secure their property rights and shape their future. We feel tremendous pride and fulfillment just watching this partnership unfold- to see how people's lives are being transformed, and how government processes may be improved as a result.

Team Member driven initiatives and Community Projects

Exciting news- especially for our Team Members! We have launched a new partnership initiative with VMBS Branches to drive community-led projects for stronger, sustainable communities. In 2023, we piloted an approach where branches were invited to collaborate with local community development partners and service organisations to address critical community needs. The idea is built on a belief that the VM Foundation's work in communities should be represented by the closest VMBS branches. We started off with six branches in 2023. Of those six, two launched projects to be implemented in 2024. Now, we are expanding this model to more branches to create widespread impact across even more communities.

In partnership with Dian Campbell Presidents' Circle (2022 VM Group awardees), through the 'Pay it Forward' initiative, VM Foundation handed over \$632,000 to Food for The Poor to build a home for a homeless family in November 2023. This was made possible by Team Member donations and support from the VM Foundation. We extend our heartfelt thanks to all involved. Your generosity will provide shelter and basic furniture, making a meaningful difference in the lives of those in need.

Parenting

Families are the building blocks of society. In 2023 we decided to maintain parenting as one of our core areas of focus. This decision was largely in response to the pandemic, having observed issues to do with parenting, striving to achieve a work life balance, being at home and an overall scarcity of comprehensive, and transparent guidance easily available. We saw this as a calling for us to fill the gap and the clear need for content and context appropriate resources for parents. Through our many initiatives under this pillar, we seek to be part of the solution. At the heart of our mission lies a profound desire to support and empower parents and guardians in their pivotal role. Through initiatives such as the Positive Parenting video series and strategic collaborations with organizations like the Women's Centre of Jamaica Foundation, we offer education, support, and guidance to parents. Our goal is to enhance parental skills, strengthen family bonds, and promote positive parenting practices that foster stability and well-being within households.

Women's Centre of Jamaica Foundation

Throughout 2023, the VM Foundation continued its support for the Women's Centre of Jamaica Foundation's (WCJF) Finishing School Programme for Adolescent Mothers—a vital initiative aimed at empowering young mothers to continue their education and develop essential life skills for a brighter future. Established in 1978, this programme provides continuing education to girls who become pregnant while attending high school and are forced to withdraw -at least until the baby is born. Many girls end up leaving school in the middle of exam preparation and cannot continue learning or sit exams in their original school. This programme gives girls the chance to do so. The VM Foundation recognizes the important role that the WCJF plays in supporting adolescent mothers to complete secondary education, learn skills, and provide for their newborn. In 2023, we supported the programme by providing financial education sessions in June for the benefit of these young mothers. Through these sessions, mothers are empowered and better able to manage their finances effectively, plan for their future, and achieve financial independence.



Adopt-a-Clinic

The VM Foundation proudly renewed its partnership to adopt the St. Jago Park Health Centre. In line with this commitment, we have been dedicated to upgrading the facility and providing essential resources to support the thousands of residents who rely on its services. In October 2023, we had the privilege of handing over much-needed equipment and appliances valued at close to J\$1.2 million, a contribution that is already making a tangible difference in improving healthcare access for our clients. In addition to our healthcare initiatives, we have also been actively engaged in commemorating Parents' Month through our Financial Wellness and Parenting Expo, hosted at the clinic each year. The expo returned at an even larger scale on November 27, 2023, thanks to the sponsorship from brands including Wisynco and National Baking Company. With these sponsorships, we were able to provide gift baskets and tokens, incentivizing crowd participation during the day's activities and enhancing the overall experience for attendees. The expo dubbed the theme 'Tek Charge' and equipped the estimated 200 attendees to take charge of their finances, take charge of their physical and mental health and take charge of their households through positive parenting practices. It also featured a Positive Parenting Poster competition, to engage

students from nearby schools. Grade 3 students beautifully expressed their artistic interpretations of positive parenting through these posters and were awarded with tablets and cash prizes totalling \$40,000.

Our commitment to holistic wellness was further underscored by specialized sessions tailored for patients, including wellness and education presentations, as well as financial literacy sessions. These sessions covered a diverse range of topics, from "Big Man Ting: A reasoning with fathers" led by Caribbean Male Action Network -Jamaica (CariMAN Jamaica), to "Transform Your Everyday," a session on financial strategy spearheaded by our financial services specialist and wealth advisors. Professionals from the health centre also delivered vital presentations on "Taking care of your newborn" and "Accidental Poisoning," offering crucial guidance on maternal and infant nutrition. Sensitization sessions from multiple organizations including the National Parenting Support Commission, the Ministry of Education, Youth and Information, and the National Council on Drug Abuse rounded out the presentations, providing invaluable insights and support to our community.

CEO Samantha Charles summarised the Foundation's motivation behind this Expo and its unique offerings like this:

At the VM Foundation, we aim to improve quality of life. How we achieve this realistically is by engaging people in environments they feel safe and comfortable in and by bringing the experts to them. But that's not all – once they have been introduced to key concepts through sensitization sessions and interactive knowledge sharing, capacity building workshops and reasonings, we also ensure that the right organisations and agencies are immediately accessible at various booths on location to help them accelerate their next steps, bringing them closer to their goal.






Parenting Digital Series

Our Positive Parenting with VM Foundation series represents more than just online content, it is an innovative and informative platform to support and celebrate parents in their journey of raising happy, healthy, and resilient children - a "digital village" if you like. This "digital village" supports parents in navigating the world of parenting and their everyday lives. CEO, Samantha Charles aptly describes this series as a "response to cries for help from parents who shared their challenges through forums and parenting hotlines during and after the pandemic. VM wants parents to know that we are here to help them and to provide resources for them to tap into – their cry for help is not going on deaf ears". While there is no set manual of instructions for parenting, we've put together this series to gather and impart ways that other parents can find solutions and practise positive parenting. We know that not everything will apply to each household, but we trust that is always a lesson - either a fresh perspective or a parenting hack that might be useful to even one mother or father.

This year, we collaborated with Tami and Wayne Mitchell, the gifted duo behind "Meet the Mitchells". Together, they have five children. As recording artists, hosts, and media personalities, Tami and Wayne Mitchell know the struggle to achieve a work-life balance all too well. Merging comedy with sound advice, the Mitchells shared their experiences in parenting and revealed strategies to foster resilience in children. The couple opened up to us, pouring out their feelings about their parenting style, showing us how their approach differs from their parents'. The couple was joined by clinical psychologist Georgia Rose, and had a frank talk about expectations that parents typically have. Georgia's key recommendation was for parents to accept their children as they are, rather than what parents imagine or expect them to be.

At the end of the month-long series, in a very vulnerable live recording in their home, Tami and Wayne told viewers about some recent experiences where they were both confronted with lessons learned in the series. They mentioned some of the adjustments they had been making since the series started. Most important of all was the reminder to actively and intentionally listen and observe their children. We are grateful for their honesty, their vulnerability and wisdom in sharing with us. As we step back to reflect on the series as a whole, we are reminded of the power of storytelling, good humour, and shared experiences in shaping our understanding of parenthood and family dynamics.

Ongoing Programmatic Support

Child Resiliency Programme

The Child Resiliency Programme has been supported by the VM Foundation since 2020 and will continue to be a beneficiary of ongoing programmatic support. The programme empowers children who are referred for being at risk for violence and who are facing adversity with the aim to build resilience in their lives, and to Build Peace, Resiliency and Wellness (PRW) in the lives of the adults responsible for caring for Children at Risk/affected by trauma. With the resumption of full-time, in-person classes after two years of pandemic-induced online learning, the Child Resiliency Programme returned, thankfully to its original cohort size of 60 at its community based model at Boys Town and expanded to include an additional cohort of 25 at its school based model at Mountain View Primary and Infant School. The participating children, aged 9-11, are identified as having adverse childhood experiences and are at risk of violence, abuse, trauma, and neglect.

The Child Resiliency Programme provides a safe environment for these children, offering literacy and psychosocial support, including life skills training, sports, creative activities, monthly parent workshops, and individual family counselling for parents/caregivers, field trips and nutritional support. In addition, two PRW workshops were held for the benefit of school and programme staff, equipping them with tools to manage their own Resilience and Well-being and better support the at-risk children.

Significant improvements have been made to the programme's training arm, and strides were made in strengthening its partnership with the International University of the Caribbean. This collaboration led to the establishment of the Peace Institute and Extended Learning Centre's office, to support the programme's mission. The PRW Curriculum including the Child Resiliency Programme model has now been integrated into the Guidance and Counselling, Education and Psychology Curriculum for undergraduate students and is a mandatory course for graduation. These efforts are guided by the Peace Building, Resiliency and Wellness Manual created by Dr Kim Scott and the CRP leadership in 2021 and the Child Resiliency Programme Handbook with Operational Guidelines which was updated in 2023 to ensure a comprehensive and evidence-based approach to supporting at-risk children and their caregivers. The Child Resiliency Programme Leadership team are now poised via the Peace Institute to offer Training and Evaluation for any potential replication sites.

Financial Education Sessions organized by the Foundation

As is customary for all VM Foundation activities, VM Team Members loaned their wisdom and insights through financial education sessions to several organisations and events this year, including staff at corporate organisations, the Women's Centre of Jamaica Foundation, the Jamaica Library Service and the St. Jago Park Health Centre. We can proudly highlight that financial education has been integrated in 12 of the Foundations 13 programmes and projects-across all areas of focus. In 2023 alone, we impacted over 1000 individuals through our sessions on financial literacy.

Thank You

In so many ways, the VM Foundation "revved up and won" in 2023. Though we are the new kids on the block, we have had a truly monumental impact since launching in 2015. We started with few programmes and partners, but have since expanded to partner with several international organisations, government agencies, and launching bigger and more impactful programmes.

All VM Foundation Team Members would agree that there is a real, innate, deep-seated commitment to transforming lives through the Foundation that just fuels our boundless creativity and innovation. It is this creativity and innovation that push us to continuously strive to find new and improved ways to address challenges and fulfil the needs of Jamaican people. Of course, we are also driven by our wider VM Group Team Members and Members who we are not only accountable to, but who boost us with new ideas, new communities and deserving heroes. Donations from Team Members and Members have empowered us to increase funding in our scholarship programme, re-launch old ones, and start new programmes in 2023. As you read this report, know that new initiatives are building momentum and in the works at the VM

Foundation. We know we can always count on our Team Members to volunteer for financial education sessions and community activities, embodying our commitment to aiving and volunteerism. Your time, efforts, and donations add immeasurable value to the VM Foundation, and by extension to the nation. We express heartfelt thanks for your ongoing support and invaluable contributions. It's through your dedication and initiatives that we continue to make a meaningful difference in our communities. As we reflect on 2023, we see the road we've travelled- the partnerships, the launches, the patients, students, speakers, participants- all a testament to our shared journey and the countless Jamaicans, here and abroad who have fuelled our progress. Each of you has played a vital role in launching us forward, providing the fuel that powers our engine of change. Look out for more in 2024, as we shift into an even higher gear!

Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of VM Foundation Limited ("the Foundation"), set out on pages 5 to 18, which comprise the statement of financial position as at December 31, 2023, the statements of profit or loss and other comprehensive income, statement of changes in funds and cash flows for the year then ended, and notes, comprising material accounting policies and other explanatory information.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the Foundation as at December 31, 2023 and of its financial performance and cash flows for the year then ended in accordance with IFRS Accounting Standards as issued by the International Accounting Standards Board (IFRS Accounting Standards) and the Jamaican Companies Act.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Foundation in accordance with the International Ethics Standards Board for Accountants International Code of Ethics for Professional Accountants including International Independence Standards (IESBA Code), and we have fulfilled our other ethical responsibilities in accordance with the IESBA Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation of financial statements that give a true and fair view in accordance with IFRS Accounting Standards and the Jamaican Companies Act, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error. In preparing the financial statements, management is responsible for assessing the Foundation's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Foundation or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Foundation's financial reporting process.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with ISAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

If we conclude that a material uncertainty exists, we are required to draw attention in our auditors' report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditors' report. However, future events or conditions may cause the Foundation to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

Report on additional matters as required by the Jamaican Companies Act

We have obtained all the information and explanations which, to the best of our knowledge and belief, were necessary for the purposes of our audit.

In our opinion, proper accounting records have been maintained, so far as appears from our examination of those records, and the financial statements, which are in agreement therewith, give the information required by the Jamaican Companies Act in the manner required.

VM Foundation Limited Notes to the Financial Statements December 31, 2023

1. The entity

VM Foundation Limited ("the Foundation") was incorporated under the laws of Jamaica on July 18, 2017 as a limited liability company. It is a charitable organisation whose objective is to improve the quality of life of Jamaicans by supporting activities that encourage literacy, skills development, healthy parenting practices, community development, financial inclusion, and economic prosperity for all Jamaicans.

The Foundation is funded principally by contributions from The VM Building Society. It is domiciled in Jamaica, with its registered office located at 73-75 Half Way Tree Road, Kingston 10.

The Foundation is an approved charitable organization for purposes of Section 13(i)(g) of the Income Tax Act. It is also exempted from income tax under Section 12(h) of the Income Tax Act. The Foundation is a registered charity (RCO) and automatically enjoys specific tax concessions for GCT, Income tax, Transfer Tax, Stamp Duty, Property Tax and the Minimum Business Tax.

2. Statement of compliance and basis of preparation

(a) Statement of compliance

The financial statements are prepared in accordance with International Financial Reporting Standards (IFRS) and comply with the provisions of the Jamaican Companies Act ("the Act").

(b) New and amended standards that came into effect during the current financial year.

> Certain new, revised and amended standards and interpretations came into effect during the current financial year. None of these standards impacted the Foundation's financial position or performance for the current financial year, except for: The Foundation adopted Disclosure of Accounting Policies (Amendments to IAS 1 and IFRS Practice Statement 2)

from January 1, 2023. Although the amendments did not result in any changes to the accounting policies themselves, they impacted the accounting policy information disclosed in the financial statements.

The amendments require the disclosure of 'material' rather than 'significant' accounting policies. The amendments also provide guidance on the application of materiality to disclosure of accounting policies, assisting entities to provide useful, entity-specific accounting policy information that users need to understand other information in the financial statements.

2. Statement of compliance and basis of preparation (continued)

(b) New and amended standards that came into effect during the current financial year (continued)

Management reviewed the accounting policies and made updates to the information disclosed in Note 3.

Details of the Foundation's accounting policies are included in Note 3.

(c) Use of estimates and judgements

Judgements made by management in application of IFRS did not have a significant effect on the financial statements, including estimates with a significant risk of material adjustment in the next financial year.

The preparation of the financial statements in conformity with IFRS requires management to make estimates, assumptions and judgements that affect the application of accounting policies and the reported amounts of, and disclosures relating to, assets, liabilities, contingent assets and contingent liabilities at the reporting date and the income and expenses for the year then ended. Actual amounts could differ from those estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised, if the revision affects only that period, or in the period of the revision and future periods, if the revision affects both current and future periods.

3. Material accounting policies

(a) Cash and cash equivalents:

Cash and cash equivalents are measured at amortised cost. They comprise cash in hand and short-term, highly liquid investments where their original maturities do not exceed three months, are readily convertible to known amounts of cash, are subject to an insignificant risk of changes in value and are held for the purpose of meeting short-term cash commitments.

(b) Accounts receivable:

Accounts receivable is measured at amortised cost less impairment losses.

(c) Accounts payable and accrued charges:

Accounts payable and accrued charges are measured at amortised cost.

(d) Related parties:

A related party is a person or entity that is related to the Foundation (reporting entity).

 - (A) A person or a close member of that person's family is related to the Foundation if that person:
 - (i) has control or joint control over the Foundation;
 - (ii) has significant influence over the Foundation; or
 - (iii) is a member of the key management personnel of the Foundation or parent of the Foundation.
 - (B) An entity is related to the Foundation if any of the following conditions applies:
 - (i) The entity and the Foundation are members of the same group (which means that each parent, subsidiary and fellow subsidiary is related to the others).
 - (ii) One entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member).
 - (iii) Both entities are joint ventures of the same third party.
 - (iv) One entity is a joint venture of a third entity and the other entity is an associate of the third entity.

- (v) The entity is a post-employment benefit plan for the benefit of employees of either the Foundation or an entity related to the Foundation.
- (vi) The entity is controlled, or jointly controlled by a person identified in (A).
- (vii) A person identified in (A)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity).

A related party transaction is a transfer of resources, services or obligations between related parties, regardless of whether a price is charged.

Transactions in foreign currencies are converted at the rates of exchange ruling on the dates of those transactions. At the end of each reporting period, monetary items denominated in foreign currencies are re-translated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not re-translated.

Realised and unrealised gains and losses arising from fluctuations in exchange rates are included in profit or loss.

(e) Revenue recognition:

Contribution income

Contributions are obtained from the VM Group Ltd and its subsidiaries, and are recognised on the cash basis.

Interest income

Interest income is recognised on the effective interest basis.

(f) Financial instruments:

A financial instrument is any contract that gives rise to a financial asset of one enterprise and a financial liability or equity instrument of another enterprise. For the purpose of the financial statements, financial assets have been determined to include cash and cash equivalents. Financial liabilities include accounts payable and accrued charges.

(a) Recognition and initial measurement:

The Foundation initially recognises the financial assets and liabilities at fair value on the trade date, which is the date on which the Foundation becomes a party to the contractual provisions of the instrument. Other financial assets and financial liabilities are recognised on the date on which they are originated. (b) Classification of financial instruments:

On initial recognition, a financial asset is classified as measured at amortised cost, fair value through other comprehensive income or fair value through profit or loss (FVTPL).

A financial asset is measured at amortised cost if it meets both of the following conditions and is not designated as at FVTPL:

 the asset is held within a business model whose objective is to hold assets to collect contractual cash flows; and the contractual terms give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding (SPPI)

The entity, or any member of a group of companies of which it is a part, provides key management personnel services to the company or to the parent of the company.

(f) Financial Instruments (continued) Business model assessment

> In making an assessment of the objective of the business model in which a financial asset is held, the Foundation considers all of the relevant information about how the business is managed, including:

- (a) the documented investment strategy and the execution of this strategy in practice. This includes whether the investment strategy focuses on earning contractual interest income, maintaining a particular interest rate profile, matching the duration of the financial assets to the duration of any related liabilities or expected cash outflows or realising cash flows through the sale of the assets; and
- (b) the risks that affect the performance of the business model (and the financial assets held within that business model) and its strategy for how those risks are managed.

a) Overview:

The Foundation has exposure to the following financial risks from its operations and use of financial instruments:

- Credit risk
- Liquidity risk
- Market risk
- Operational risk

10. Financial risk management

a) Overview (continued):

This note presents information about the Foundation's exposure to each of the above risks, the Foundation's objectives, policies and processes for measuring and managing risk and the Foundation's management of capital.

The Board of Directors of VM Group Limited has overall responsibility for the establishment and oversight of the Foundation's risk management framework.

The Board has established the following committees for risk management purposes:

- (i) Group Finance and Risk Management Committee
- (ii) Corporate Governance, Nomination and Compensation Committee
- (iii) Audit Committee
- (iv) Group Digital and IT Committee

These committees are responsible for developing and monitoring risk management policies in their specified areas. All Board committees are comprised of non-executive members and report to the Board of Directors on their activities. The Group Finance and Risk Management Committee is responsible for implementing an integrated approach to risk management across the Group and ensuring its effectiveness consistent with the strategic risk appetite of the Group. Risk management policies and systems are reviewed regularly to reflect changes in market conditions, products and services offered. The Group, through its training and management standards and procedures, aims to develop a disciplined and constructive control environment in which the Board, management, team members and all stakeholders of the Group understand their roles and obligations.

There are, in addition, an Asset and Liability Committee ("ALCO"), a Credit Committee and an Executive Enterprise Risk Management (ERM) Committee, comprising members of executive management. These Committees report to the Group Finance and Risk Management Committee of the Board. The ALCO has responsibility for liquidity management, interest rate and foreign exchange risk management, capital adequacy management and oversight of treasury performance. The Credit Committee has responsibility for the implementation of appropriate policies and procedures to support the credit review and approval process for the Group. The Executive ERM Committee provides oversight for the Group's ERM framework, including methods, policies and procedures to identify, assess, monitor and report on material risks to the Group's key performance objectives.

Financial risk management (continued) 10.

(b) Credit risk:

Credit risk is the risk of financial loss to the Foundation, if a party or counterparty to a financial instrument fails to meet its contractual obligations.

For risk management reporting purposes, the Foundation considers and consolidates all elements of credit exposure.

Credit quality analysis:

Credit risk exposure is the amount of loss that the Foundation would suffer if all counterparties to which the Foundation is exposed were to default at once. The maximum credit exposure is represented by the carrying amount of the financial assets shown on the Statement of Financial Position as at the reporting date. There is no off-balance sheet exposure to credit risk.

The Foundation maintains cash and cash equivalents with reputable financial institutions. These financial assets are held with regulated financial institutions and collateral is not required for such accounts, as management regards the institutions as strong.

(c) Liquidity risk:

> Liquidity risk is the potential for loss to the Foundation arising from either its inability to meet its obligations or to fund increases in assets as they fall due without incurring unacceptable costs or losses. The management of the Foundation manages this risk by maintaining adequate financial assets in liquid form and schedules the timing of the settlement of its commitments with the expected receipt of funds from VM Group Limited and its subsidiaries. Liquidity risk is broken down into two primary categories:

- (j) Funding liquidity risk - the risk that the Foundation will not be able to meet the expected and unexpected current and future cash flows and collateral needs without affecting either its daily operations or its financial condition; and
- (ii) Asset/Market liquidity risk - is the Foundation's inability to liquidate assets in an orderly fashion and the resulting loss on liquidation. This usually stems from illiquid markets or market disruptions.

The Foundation's financial liabilities that would create an exposure to liquidity risk comprise of accounts payable and accrued charges. The following are the contractual maturities of financial liabilities.

(d) Market risk:

Market risk is the risk that changes in market prices, such as interest rates, foreign exchange rates and equity prices will affect the value of the Foundation's assets, the amount of its liabilities and/or the Foundation's income. The Foundation has no significant exposure to foreign currency risk, equity price risk or interest rate risk. (e) Operational risk:

Operational risk is the risk of direct or indirect loss arising from a wide variety of causes associated with the Foundation's processes, personnel, technology and infrastructure, and from external factors other than credit, market and liquidity risks such as those arising from legal and regulatory requirements, natural and man-made disasters as well as generally accepted standards of corporate behaviour.

The Foundation's objective is to manage operational risk to achieve the optimal balance between the Foundation's financial viability and its performance against the requirements of an effective operational risk management framework.
